What is Teen Dating Abuse?


A pattern of actual or threatened acts of physical, sexual, and/or emotional abuse, perpetrated by an adolescent against a current or former dating partner.

What is Sexual Abuse?

Sexual violence occurs whenever a person is forced, coerced, and/or manipulated into any unwanted sexual activity.

What is Domestic Violence?

Domestic violence is not physical violence alone. It is any behavior the purpose of which is to gain power and control over a spouse, partner, girl/boyfriend or intimate family member.
